# Highlights of 2018

What a great year for the Foggy Bottom West End Village! We did more programs than ever before, deepened our understanding of social isolation and how to treat it, provided services to our members as requested, and strengthened the stability of the Village.

**Volunteers:** In addition to having a full-time executive director and part-time program specialist on staff, we also had strong volunteer leadership and many hard-working volunteers behind the scenes, making everything from the Gala to the weekly programs come together. Countless hours were spent identifying program speakers, setting up locations and other logistics, and publicizing activities. Volunteers head up every affinity group, checking in with instructors and participants, and making sure these weekly or monthly activities run smoothly. Volunteers also respond to virtually all of our service requests.

**Board of Directors:** The Board of Directors, volunteers all, ensure we meet all federal and local requirements for non-profits, raise critical funds, and oversee all financial activity, enabling the Village to be the best possible steward of its assets. Additionally, they provide the strategic vision for the organization, keeping the Village focused on its mission. In 2018 they completely revised the Directors' Manual and approved the rewritten membership and volunteer manuals as well. Several new board members joined during the year bringing valuable skills and more energy.

Fundraising: We introduced the Legacy Giving Program with 10 founding members, all committed to including FBWEV in their wills. During 2018 we received two large bequests totaling \$25,000. Other fundraising included a successful annual appeal and, of course, the Gala, honoring Susan B. Haight with the annual Founders' Torch Award for Community Service which exceeded our fundraising goal. More than 75 people enjoyed the silent auction, the Wall of Wine, and the delicious food. All of this generous support enabled the Village to expand the number of reduced fee members and maintain its many programs and services.

Social Isolation: In 2018 FBWEV implemented a \$71,000 grant from the DC Office on Aging (DCOA). As part of this project, we hosted a special learning series on the topic of aging and social isolation. This public event included a panel discussion of outstanding academics and experts on of the topic of social engagement, including how to recognize and address social isolation. The concluding component of the event was an activity fair which gave participants the opportunity to explore innovative solutions and learn about new ways to stay connected, including using technology as a tool for social engagement.

**Services:** The Village, through our corps of vetted volunteers, offered a wide array of services to our members. The most popular was transportation - rides to medical appointments, social activities, and personal errands. Members also benefited from technical assistance - setting up new equipment, troubleshooting existing equipment, and explaining how to use various software. Volunteers ran numerous errands for members including grocery shopping and going to a pharmacy to pick up medications or to a post office to drop off packages. Other services utilized included minor home projects, help organizing and/or completing paperwork, and accompaniment to medical appointments.



### **Programs**

**Outstanding programs** in 2018 included four art tours ranging from The Textile Museum to The Phillips Collection and book discussions which were always crowd-pleasers. These included the author-led discussion on "The Watergate: Inside America's Most Infamous Address."

**FBWEV hosted** six current event discussions and three lectures on varying topics from "Finances for Today & Tomorrow" to "Harriet Tubman: A Woman Called Moses." We were also able to provide our members with two private tours of the Supreme Court.

Our Health and Wellness programs, always of great interest to members, included How Healing Works, What's for Dinner, Stress Management, and Stepping Safely into Winter. Another set of programs which included some of the highest attendance focused on technology, starting with an overview, followed by four sessions addressing specific tech issues related to iPhone use.



Affinity Groups for FBWEV are interest-specific groups which meet regularly (weekly or monthly) and are led by a volunteer. These change over time as members' interests evolve, but Affinity Groups for 2018 included: Gentle Yoga, Guys at Lunch, Mindfulness Meditation, Caregivers' Support Group, Sports Discussion Group, Qi Gong, Walkie Talkies, and the Women's Lunch Group.

Last, but far from least, FBWEV always has very popular social events. These include four Happy Hours and our annual Ice Cream Social, a summer highlight. We offered two backstage tours — one at Arena Stage and "Backstage at The Kennedy Center Honors: From the Green Room To The Podium." And most popular of all were our Village Cabaret, featuring easy listening hits, and our year-end Holiday Party because having fun is always a Village priority!

### **Programs and Affinity Groups: 424**

Curated museum and art gallery tours, coffee gatherings, health and fitness workshops, book groups and singing groups, happy hours, current event discussions and well attended workshops on technology, along with scores of other activities, kept FBWEV members busy and engaged. If it was of interest to seniors, we addressed it!

Volunteers make this Village what it is! They plan and manage all the programs, coordinate the affinity groups, plan and implement the annual fundraiser and work in the village office. In addition our volunteers fulfilled over 75 formal requests for transportation and other services.

What you don't see in those formal requests are all the informal requests that are made to fellow village members. The primary function of a village is to create a sense of community, to help people build relationships and a supportive "safety net." As a result of successfully creating networks many Villagers now turn to someone they consider a friend – someone they got to know through the village – when they need a ride or help with something in their home. If we counted these services the number of requests would likely match the number of our programs!

### Village Members: 157

Membership continued to grow in 2018, with a 7% increase over 2017. Members recruit new members — word of mouth is the best source of publicity we could have. Of that membership, 17% are reduced fee members, meaning their membership fee ranges from \$0 to \$100. The remaining part of their membership fees are raised by the Development Committee for that specific purpose and are not taken from other members' dues. We are pleased to note that this is the highest percentage of subsidized members of any village in D.C.

### Financial Overview

Financially the Village had another strong year. A net income of about \$8,000 added to the cushion built by our founders and others to ensure the sustainability of the Village, and total assets reached almost \$341,000. This was our first full year with a full-time Executive Director, as well as a part-time senior program specialist, and -- typical for Villages -- staffing was our biggest expense. A major grant from the DC Office of Aging (DCOA) financed our work on combating social isolation. The spring Gala netted about \$47,000; two donors gave \$7,360 to help subsidize reduced fee memberships; and more than \$83,000 was provided by other donors, including bequests and our Annual Appeal. We are so grateful for all this generous support.
